#### **Executive updates:**

- 1. The Governor's office is very prompt in attending to the approval of our distribution grids.
- 2. The DCA draft appendix for adding Habitat as a contract administrator is attached for your information.
- 3. Senate Appropriations bill had an added line item for directed grant funding for the Trust Fund. At last review early today the item remains in the conference committee budget. CJ – the item is for directed funding that would go the Side by

BB – hope that the Commission will include Side by Side in the Commission strategic planning session. CJ – this is probably not the right forum, perhaps they would like to address the Commission at our next meeting. GM – it would be good to get their perspective.

CY – we can create an agenda item if appropriate.

HB576 CJ - was introduced by Rep. Williams to move the Commission up in the partial payment priority list. We will be go to the Capitol later today to discuss the bill with the sponsor.

- 4. The MOA for the TBI grant between the Commission and DHS has been turned in to DPH legal office. Kenisha is drafting 2020 contract action requests for DPH so we can have everything ready when the next budget year begins. DPH has yet to submit the Commission's Prior-Year amendment for funds for FY2019 and has yet to ok the Commission office supply order that has been awaiting approval for months.
- CJ what is the law enforcement perspective on the GA Supreme Court ruling on the implied consent rule for the breathalyzer refusal? HF state police no longer read the statement regarding refusal will be used against them in a court proceeding. That is no longer allowed.
